Title: Kauai World War II Morale Committee and Kauai WW II Internment

Extent: 0.5 linear feet (4 white binders)

Abstract:

This collection was compiled by Roy Miyake and consists of two parts, both having to do with Kauai during WW II. A folder on the Morale Committee includes posters and handwritten or typed statements used in an exhibit for the Kauai Museum in 2009. The Kauai Morale Committee was the chief liaison of the army with the Japanese community. The remaining three folders have to do with the detainment and interment of Kauai residents of Japanese ancestry during the war. Records of individuals, their professions, family members, and their internment locales are included.

Acquisition information: These records came to the historical society October 18, 2016. They were donated and compiled by Roy Miyake.

History:

In Oct. 1941 the US government declared Martial Law in Hawaii. In general all Hawaii residents were subjected to blackouts and gasoline and food rationing. Moreover, residents of Japanese ancestry, whose loyalty were questioned, were subjected to suspicion and scrutiny and were under the threat of internment. Japanese culture was dismantled; language schools, religious institutions, and business and social associations were closed. These records, compiled by Roy Miyake describe actions taken by the US Government on Kauai during the years 1941-1946. The Kauai Morale Committee of WWII served as the army's liaison with the Japanese community on Kauai. The goal of the committee was to alleviate fear and misunderstanding among the Japanese citizenry and to direct efforts toward the war effort and victory. Roy Miyake's grandfather was one of the founding members of the Kauai Morale Committee. These Kauai Morale Committee records were used as part of a 2009 exhibit "Nisei in Hawaii." Later Mr. Miyake undertook a larger project to identify those who had been detained and interred during the war years. The records detail names, families, reasons for detainment, internment sites, and movements following internment.

Scope and Content:

These documents are contained in 4 binders; one on the Kauai Morale Committee) and 3 on detainment and internment of Kauai residents in WWII. The first folder (#1) contains posters that were used in an exhibit (the Kauai Morale Committee) along with handwritten and typed notes. The three folders:

These albums include photos, newspaper clippings, and lists of those who were detained and/or interred during WWII. The compiler sought to identify detainees by exhibiting their photos at various events on Kauai (O-bon festivals, etc.).
