## Kauai County Charter Review Commission

#### 1965-1966

In 1900, the islands became part of the territory of Hawaii. Beginning in 1905 counties were able to establish their own charters.

Kauai elected a Board of Supervisors – starting with 5 supervisors elected by districts; changed to at-large elections, and finally to 7 supervisors elected by district. Many decisions made by the supervisors about the structure and duties of the county government have survived over the years

The Board of Supervisors penned and enacted the Charter for the County of Kauai in 1964. With the passage of S.B. no. 973 in 196 all counties were required to have a county charter with uniform structure and wording.

Kauai County Charter Review Commission met weekly beginning in December 1965 with input from county departments, the Board of Supervisors, the public, and documents submitted from other sources. Information about the council-manager plan, code of ethics and non-partisan elections were reviewed and discussed. The Proposed Charter 1966 was completed and is included in this collection.

#### Scope:

This collection was originally housed in the Lihue Library. It lacks some meeting minutes, includes supporting documents and the proposed 1966 Charter. The weekly meetings provided commission reviews of sections of the 1964 Charter.
