Bob Schleck - Seven Kauai Projects, 1987-2008

Scope and Content

This collection is a small sample Schleck's years of involvement caring for the places and peoples of Kauai. There are seven areas included: Koloa Marketplace, Lihue Historic Core and Civic Center areas, the Hanalei Road and Taro cultivation, the Kilauea Lighthouse, Maha'ulepu, and the Lihue Plantation Mill and Haleko Road. All were major issues in the late 1980s and into the early 2000s. The material in this archive is limited in volume, while showing his ability to network with others to improve our communities.

Biography

Robert J. Schleck's appreciation for historic sites began when he helped restore an old building his father had acquired in Wanakee, Wisconsin.

He moved to Kauai in 1969. In 1971 Bob began working for Mabel Wilcox to inventory the family collections at Grove Farm – George Wilcox's plantation home. Miss Mabel Wilcox, his niece, was a lifelong preservationist. She bequeathed the homestead, Waioli Mission and Mahamoku Beach houses, and other historic sites to the community, with Bob helping her with the planning process.

As Director of the Museum, Bob's ability to manage projects and obtain grants to fund preservation was a perfect fit – he opened the historic locations to the public and developed programs highlighting the unique history of Kauai. He authored <u>The Wilcox</u> <u>Quilts in Hawaii</u>, and was the driving force of obtaining and maintaining the largest collection of operating Hawaiian stream locomotives in the world.

Recognized as a leader, he served as Co-Chair of the Kauai County Building Restoration Committee for 22 years; President of the Hawaii Museums Association, and on the board of the Lihue Cemetery. The Kauai Historical Society valued his 45-year membership, and his participation as an active Board member. He was an expert in preservation and motivation, assisting many others with their projects.

After Hurricanes Iwa and Iniki, his knowledge, supervision and foresight helped fully restore the Waioli Corporation's properties for generations to enjoy. Bob was often called upon to help others with projects – and his guidance was always appreciated.

Bob Schleck is remembered as being ready to help in preservation, historical research, assist in island conservation, and motivation. He passed away on October 15, 2018. His contributions to Kauai are too numerous to count.
