## Scope and Content

This collection of legal documents date from 1853. Included are labor contracts, land sales, mortgage documents and Territory of Hawaii Real Property Bills for the years 1937 through 1943 for real estate on Kauai. Two miscellanous items are a Certificate in Japanese and a 1925 Kauai High School diploma.

Yamamoto's 1902 labor contract with Waimea Sugar Company included additional employees: T. Hiramoto, D. Tani, H. Mukai, T. Okayama, K. Sakimaye, S. Hayashi, M. Kiso, T. Kashiwabasa, H.Morikawa, K. Matsuda, I. Kimura, N. Nakagawa, H. Horigawa, R. Asai, E. Yamamoto, and Y. Otsubo.

These records were donated to the Kauai Historical Society on September 24, 2018 by Gloria Yamamoto Matusuba. These records are open to research. Processed by Marylou Bradley in September 2021 with funding provided by a Rise Up grant Kauai Historical Society Accession no. 2018.007.001-018

Whitney and his wife; E.M. and Solomon McCall, all present at this time. Signed by Thomas Brown, Registrar of Conveyances
- 2018.007.008 Conveyance signed by Mrs. Popo, wife of W.B. Aka; notarized by T.L. Brandt
- 2018.007.009 Conveyance signed by A. Kaukau and his wife H. Napaeaina; notarized by T.L. Brandt: both of these two documents were signed on February 27, 1894
- 2018.007.010 Kauai High School Diploma for Kotsue Yamamoto, June 10, 1925
- 2018.007.011 Waimea Sugar Mill Labor Agreement dated November 29, 1902, with E. Yamamoto, and 15 others, to cultivate, maintain and harvest sugar on property provided by Waimea Sugar Mill Company, with compensation noted
- 2018.007.012 Frances Gay of Kekukpua acknowledges full payment of the mortgage dated May 4, 1911 made to S. Makaila and Maryann, his wife, on Mary 11, 1914. Signed by Frances Gay, notarized by T. Brandt. Includes survey of A. Kaukau Kuleano O Kanuwahine, July 24, 1852
- 2018.007.013-A Certificate, in Japanese
- 2018.007.013-B Labor Contract : Honokaa Sugar Company with Isekichi Yamamoto, dated January 19, 1895. Notation on back indicates it was cancelled March 4, 1895 by J. Watt, manager
- 2018.007.014 Mortgage between Frances Gay, S. Makaila and Maryann Makaila for a Waimea land purchase, dated May 8, 1911 Description provides additional information on previous ownership of the property.
- 2018.007.015 Samuel Makaila purchases the real estate owned by Aholo Kaukau at auction May 3, 1911; includes registration of conveyance
- 2018.007.016 Mortgage provided to S. Makaila and Maryann Makaila, his wife, by Frances Gay, signed May 4, 1911
- 2018.007.017 Lucy A. Wright of Waimea, sells her property on June 2, 1914, to Manuel J. Carvalho of Makaweli, for \$2,000; previously owned by S. Makaila and Maryann, his wife
- 2018.007.018 Manuel J. Carvalho and wife, Francis, sells a property to M. Yamane on May 9 1916, the deed was recorded on May 20, 1916
