Abstract: This collection contains materials relating to the life and career of Judge Benjamin M. Tashiro. It contains newspaper articles and correspondence related to his judgeship, numerous speeches made at various gatherings between 1957 and 1987, and work that Tashiro did for various clubs and organizations. The collection also includes several photographs of Judge Tashiro and his family as well as a more indepth biographical sketch prepared by Benjamin Tashiro himself.

Biographical Sketch:

Benjamin Masaru Tashiro was born on May 23,1904 on the island of Kauai. He graduated from the Japanese High School "Hawaii Chuugakko" and Territorial Normal & Training School (1917-1921). He went on to attend Coe College in Cedar Rapids, Iowa from 1925-1927 and then UCLA in 1929. He studied law at Hastings College of Law at the University of California in San Francisco from 1929-1932.

From 1921-1925 Benjamin Tashiro worked as an elementary school teacher. He then engaged in private law practice in Lihue after being admitted to practice law in all courts ofHawaii in November of 1932. This made him the first American of Japanese ancestry to open a law practice on Kauai. In 1943 he volunteered and enlisted in the Military Intelligence Service Branch of the United States Army, serving at the Language School at Camp Savage and Fort Snelling, Minnesota. He rose to the rank of Master Sergeant and was honorably discharged in December of 1945.

After returning to Hawaii he was eventually appointed as a Judge of the Fifth Circuit Court of the Territory of Hawaii in 1955. This appointment lasted for a 4-year term and in 1959 he was reappointed for a 6-year term. He was appointed again in 1965 and served until his retirement in 1969. During his career Tashiro Held membership in numerous community and charitable organizations including the United Japanese Society of Kauai, the MIS (Military Intelligence Service) Veterans Club of Kauai, the Kukuiolono Community Association and many others. He served in leadership roles for several of these organizations and did a

considerable amount of legal work for these and other clubs and organizations on Kauai.
